

Judging Panel 2024

GENERAL INFORMATION FOR TE REO MĀORI JUDGES

Expressions of interest in being a judge of Te Kura Pounamu category at the New Zealand Book Awards for Children and Young Adults are invited from members of the public with relevant experience, and from the children's literature community. They may be authors, publishers, academics, reviewers, critics, booksellers, kaiako, librarians, and beyond. What is important is that they have:

- A wide knowledge and appreciation of New Zealand children's literature.
- Relevant experience and/or qualifications and a recognised standing in the field of children's literature.
- An appreciation of book illustration and design.
- Fluency in te reo Māori.
- A deep knowledge of te ao Māori.
- The ability and a commitment to work to the timelines required for the judging process.
- The availability to travel as required to judging panel meetings and to the awards ceremony.

Three judges will be selected to deliberate Te Kura Pounamu Award, which is given for books written entirely in (or translated entirely into) te reo Māori. The selection process will be undertaken by the New Zealand Book Awards Trust Te Ohu Tiaki i Te Rau Hiringa, who will appoint one of the three judges as panel convenor.

The Trust will also separately select and appoint five judges to the English language judging panel, which will deliberate over titles submitted in the English language categories and the Illustration category. Bilingual books are eligible in the categories which the English language panel will judge, and the organisers welcome applicants with a deep knowledge of te ao Māori and te reo Māori, to provide a Māori lens on both these and all the entries. Role of Te Kura Pounamu judging panel

The three-person judging panel has responsibility for:

- Working with the Awards Administrator to meet judging deadlines.
- Reading all books entered (approximately 15) and establishing a shortlist of up to five titles (of any genre) for Te Kura Pounamu Award
- Attending one briefing meeting and at least three judging meetings (via Zoom), as well as the awards ceremony.

- Selecting a winner for Te Kura Pounamu Award.
- Providing advice to judges on the English language panel regarding books written entirely in te reo
 Māori that are eligible for either the Illustration or Best First Book awards.
- Together with the English language judging panel, selecting the Margaret Mahy Book of the Year from the six main category winners (including Te Kura Pounamu winner, but excluding Best First Book).
- Sharing the tasks of writing comments on each of the finalists for the finalists' booklet and website, and preparing speeches and citations for the winning books to be read at the awards ceremony.
- Contributing to the preparation of a confidential report on the judging process for the Book Awards Trust.

Role of the convenor of Te Kura Pounamu judges

The convenor of the three-person te reo Māori judging panel has responsibility for:

- Selecting the remaining judges in discussion with the Book Awards Trust.
- Attending one briefing meeting and at least three judging meetings (via Zoom), and the awards ceremony.
- Guiding the judging process, in consultation with the Awards Administrator.
- Ensuring deadlines for judging are met.
- Developing a strong rapport with the English language judging convenor to facilitate collaboration of the two panels.
- Advising the Awards Administrator, in confidence, of the judges' decisions on the finalists and winner, by the agreed deadlines.
- Assisting the English language panel as required with input and advice regarding any bilingual entries
 in the English language categories, and any elements of te ao Māori in English language or bilingual
 entries.
- Liaising with the Awards Administrator and publicist on administration and public relations questions.
- Representing the judging panel in media and public relations activities (e.g. meeting with sponsor representatives, press interviews). The convenor must be available (possibly during the day or evening) for media interviews for the key periods of the finalists' and winners' announcements.
- Writing comments and statements on the finalists and winner for publication on the website and in the finalists' booklet.
- Preparing a statement providing an overview of the judging process and commenting in general
 terms on the nature and calibre of the entries, how the judges approached their task etc, to be read
 at the awards ceremony.
- Participating in presentations at the awards ceremony.
- Preparing a confidential report on the judging process, with recommendations, for the Book Awards
 Trust.

Role of Awards Administrator

It is the Awards Administrator's role to support and assist the judges in the judging process and to ensure deadlines for the judging process are met. While the Awards Administrator may attend some judging meetings, they have no involvement in the judging decisions. Judges may call for advice or assistance at any time during the judging process and should direct all communication through the Awards Administrator.

Judging Timeline / Commitment

2023

25 Oct – Expressions of interest due from potential judges

Mid Nov – Judging panel confirmed

16 Nov – Call for submissions from publishers for 2024 NZ Book Awards for Children & Young Adults

Early Dec – Judging panel announced (media release)

Early Dec – Judges' briefing meeting (via Zoom)

Mid-Dec 2023 to end Mar 2024 – Judges' reading period. Books will be sent to the judges in batches (approximately 20 books in total)

2024

Early April – Judges' finalists meeting (via Zoom)

Mid- to late May – Judges' category winners meeting (via Zoom)

Mid- to late June – Judges' meeting to decide the Margaret Mahy Book of the Year (via Zoom)

Early to mid-August – Awards Ceremony (in Wellington)

Honoraria & Expenses

Judges receive a full set of books submitted for the te reo Māori category together with an honorarium for Te Kura Pounamu judges of \$300 (ex GST, before tax). The convenor of Te Kura Pounamu judges will receive an honorarium of \$400 (ex GST, before tax).

Travel for attendance at meetings and the awards ceremony will be arranged by the Awards Administrator and costs borne by the Trust. Any other reasonable expenses which are incurred by the judges in connection with their task, such as postage or telephone calls, will be reimbursed.

Selection process

Te Kura Pounamu judging panel will be selected by board members of the New Zealand Book Awards Trust, along with the Awards Administrator and 2024 convenor of judges. Geographic and community representation, as well as relevant qualifications and experience, will all be considered in the final makeup of the panel. The Book Awards Trust reserves the right not to appoint from the applications received, and reserves the right to appoint by invitation. Unsuccessful applicants will be advised before the panel is announced, and are welcome to reapply in subsequent years.
